  - c. Seatbelts for Road car to WOF standards or Competition vehicle full harness 4 or 5 point secured
  - d. Valid WOF or basic Competition/race standards. Eg No wired or clamped springs no leaking suspension units, no loose wheel bearings
  - e. It is advised to remove wheel hub caps so wheel bolt nuts can be observed at any time
  - f. Engine oil catch cans required if crankcase breather not vented back into the air intake system, tires speed rated for anticipated speeds eg Z max 149mph, W max 168mph, Y max 186mph (Y) plus 186mph
  - g. Snug fitting helmet, full race, less than 10 years old, that complies with one or more of the approved international standards:i. Helmet Standards for Car Entrants
