

Landspeed New Zealand - Indemnity Form

- I understand and accept that Motor vehicle Racing/Competition can be dangerous and may;
 - o Cause me injury, serious or even death.
 - o Damage my property.
- I agree that in the context of this agreement, that 'my property' includes any property owned by me or in my possession or under my control.
- Neither I, nor anyone associated or connected with me, will make any claim against Landspeed NZ Association and their officers, volunteers, Marshals, or agents (hereon collectively referred to as LSNZ Assn.) in respect of;
- Any injury suffered to me.
- Any damage to any of my property regardless of how the injury or damage occurs.
- I will release, hold harmless and indemnify LSNZ Association against all claims, damages, and losses (including costs) that they may incur as the direct or indirect result of any injury to me or damage to my property.
- I will not imply LSNZ is liable for damages to my engine if I exceed the rev limits of my engine.
- LSNZ Accepts that this indemnity will not affect my legal obligations that LSNZ Association, have to me which they cannot contract out of under New Zealand Law.
- I agree that this agreement and indemnity will be binding on my family, my heirs, my legal assigns and my administrators and executors.
- LSNZ reserves the right to use this signed indemnity form in court or any other investigation as evidence you have agreed to the terms on this indemnity.
- LSNZ reserves the right to use any media pictures or film in a investigation into any incident/accident.
- LSNZ will if there are reasonable grounds for an investigation use your personal details as supplied on entry forms.
- LSNZ will take all care and due diligence but no liability for any film/pictures taken of a accident or incident and is why there is no live streaming but a delay of 5 to 10 minutes.
- I am physically fit and there is no health or other reason why I should not participate in the sport of motor vehicle Competition.
- I attest that I am competent Driver/Rider and have the necessary skills to participate safely in this event.
- I am over 18 years of age.
- I am responsible at all times for the condition and safely of my motor vehicle and safety gear/helmet.
- I will not, allow anyone not registered for this event to Drive/Ride my motor vehicle on the road course.



- I will attend the morning Drivers/Riders participant briefing on day that I participate in the event.
- I will obey all instructions given to me by LSNZ Assn., both verbal and non-verbal (for example, flags or lights), whilst taking part in this event.
- I will not take part in this event whilst under the influence of drugs or alcohol. I
 understand that LSNZ Assn. Supports the FIM/IOC Charter on drugs in Sport and that
 LSNZ Assn. Will use the services of the Medics or NZ Police to professionally carry
 out drug/alcohol testing. I acknowledge, by signing this form, I may be subjected to a
 drug/alcohol test at any time. I agree to such testing.
- No smoking or vaporing or alcohol consumption or pets during event hours, in the
 pits and spectator paddocks of some 9.5 hectares. There is a high fire risk with dry
 grass and forestry everywhere.
- I understand that my entry to this event may be immediately cancelled without refund if LSNZ Assn. has reasonable grounds to believe that any of the terms have been breached.
- I understand that entries to this event may be limited for organisational reasons and that LSNZ Assn. are under no obligation to accept my entry.
- I will not bring Landspeed New Zealand Association into disrepute or discredit by electronic or written or verbal means.
- I understand that refunds, for whatever reason, are at the sole discretion of LSNZ Assn. and that LSNZ Assn. will not enter into any correspondence with regard to any claim that may arise from my participation in this event. I certify that the information provided on this form is correct.
